OUR PURPOSE

CIS of Virginia supports the growth and sustainability of a statewide network of six independent affiliates and a new affiliate serving rural communities in Southside Virginia. The state office:

- Strives to provide affiliate leaders, staff and boards with the knowledge, tools and resources that build strong and sustainable organizations.
- Identifies opportunities for growth and develops new partnerships to expand the reach and impact of CIS.
- Ensures fidelity to the evidence-based model that has proven to deliver high-quality supports to the students who need them most.





CIS of Petersburg was identified as a key community organization in Governor Youngkin's Partnership for Petersburg initiative. Along with funding support, the initiative sparked opportunities to engage with First Lady of Virginia Suzanne Youngkin. During one visit, Mrs. Youngkin joined CIS site coordinator Natasha Johnson in honoring teachers during Teacher Appreciation Week.



In 2022-23, CIS-VA supported its network of affiliates by:

Resources

- Providing **\$2,483,000 in pass-through funds** to affiliates
- Administering \$5M in Community School Funds awarded by the VDOE to support new and expanded programming in the network
- Administering Governor's Emergency Education Relief Funding to support CIS of Petersburg

Network Growth

- Engaging in strategic funding discussions to help guide the **next phase of expansion**
- Growing staff to support expansion in existing affiliates and new regions

Network Support

- Hosting a two-day CIS-VA Network Summit, convening more than 130 network staff for learning and connection
- Conducting affiliate-specific trainings
 across the network
- Providing customized data and evaluation support and training
- Facilitating cross-affiliate collaboration
- Introducing a refined Emerging Leaders Fellowship to foster leadership development and staff retention in affiliate network
- Publishing monthly e-newsletter focused on learning and professional development for site coordinators
- Implementing a **new tool** to identify social-emotional learning needs and measure outcomes

2022-23 CIS-VA Highlights

STATE OFFICE GROWTH



CIS-VA welcomed Leanne Lytle in August 2022 as Director of Program and Evaluation. In this role, she engages and serves all levels of the CIS-VA network to implement and evaluate effective programmatic practices while cultivating collaborative, positive relationships with affiliate staff and driving network-wide professional development. Among her contributions since joining CIS-VA, Leanne has helped plan and execute two network convenings, redesigned the Emerging Leaders Fellowship and created a learning curriculum for new site coordinators.



CIS-VA successfully proposed and advocated for two funding initiatives critical to growth of reach and impact across the state:

- Increased allocation in Virginia Department of Education budget to **\$2M/year** to support state office and network sustainability as well as growth to new high-need regions of the state.
- Creation of a \$10M Community School Fund for the development and implementation of the community school framework in school divisions. Funding legislation also called for the Virginia Department of Education's ongoing leadership in formalizing the community school framework in Virginia and exploring other related policy initiatives. In addition to CIS-VA's award, the Community School Fund is supporting 14 non-CIS school divisions in implementing community school initiatives.

FUNDING

CIS-VA received:



from the Virginia Department of Education's Community School Fund, an initiative to develop, deepen and expand the community school framework across the Commonwealth. Over the 2023 and 2024 school years, the funds are supporting five affiliates in strategic growth in new and existing partner districts, and helping establish CIS-VA's new presence in Greensville County and Danville.

\$**977K**

in Congressionally Directed Community Project funds from Senator Mark Warner and Senator Kaine. The funds are supporting the network in adding school-based staff to support attendance and ongoing re-engagement initiatives in the 2023-24 school year.

\$**100K**

in grant funding as part of No Kid Hungry's continuing effort to ensure all children in Virginia remain healthy and able to reach their full potential. Funding went to food security initiatives throughout the statewide network and allowed all six affiliates to expand student and family access to food through grocery gift cards, food pantry supplies, community food distributions and more. From September 2022 through June 2023, 15,769 students were served by more than 3,000 documented supports.

2022-23 CIS-VA Highlights continued

NETWORK LEADERSHIP DEVELOPMENT

The **Engagement & Learning Fellowship** was introduced to provide a unique leadership development opportunity to school-based staff across the network. Throughout the year, the fellows helped shape peer learning, assisted in planning the annual CIS-VA Summit, and served as valuable sources of insight into the needs and challenges of school-based staff across Virginia. PROGRAM INNOVATION

All CIS-VA network elementary schools were provided access to the **Devereux Student Strengths Assessment (DESSA)**, a widely-used and easy-to-administer measure of **social and emotional skills**. Grounded in research, the DESSA platform gives CIS coordinators the ability to view impact in real time and drive meaningful change using a suite of evidence-based, data-informed growth strategies. Using DESSA, coordinators evaluated 2,000 case-managed elementary students across the state, gaining insight into students' need for additional support. Those identified as needing interventions received targeted supports to develop skills such as goaldirected behavior, personal responsibility, optimistic thinking and social awareness. As a result, 47% of students improved their overall social-emotional competence. Affiliates utilized this data to demonstrate the CIS's ability not only to provide programming that specifically targets this important set of skills, but also accurately measure the impact of this work.


In the 2022-23 school year, significant growth in breadth and depth continued throughout the network. In total, our affiliates added:

NETWORK GROWTH: SCHOOLS AND STUDENTS SERVED








% SCHOOLS WITH GOALS








2022-23 Financial Report

Investment from the community is essential to our ability to expand CIS's reach, support affiliate excellence and report on outcomes. We are grateful for our partners in both the public and private sectors who share our commitment to ensuring every child has the opportunity to succeed in school and beyond.

In 2022-23, CIS-VA's resource development efforts resulted in more than \$2.4M in direct support for the affiliate network. Pass-through funds supported affiliate growth and sustainability in the form of investment in affiliate infrastructure and leadership, support for new site coordinator positions and a one-year hunger-relief initiative. **REVENUE** \$3,890,383
