# **Our Purpose**

CIS of Virginia supports the growth and sustainability of a statewide network of six independent affiliates and a developing affiliate serving rural communities in Southside Virginia. The state office:

- Strives to provide affiliate leaders, staff and boards with the knowledge, tools and resources that build strong and sustainable organizations.
- Identifies opportunities for growth and develops new partnerships to expand the reach and impact of CIS.
- Ensures fidelity to the evidence-based model that has proven to deliver high-quality supports to the students and families that need them most.



# All In for Kids for 25 Years

In 1999, CIS of Virginia was established to serve as a hub for growth and sustainability of a statewide affiliate network dedicated to advancing the commonwealth's vision of maximizing the potential of all students. Since that time, the CIS network has grown from three affiliates serving three districts and 33 schools to six affiliates serving 176 schools in 26 school divisions, making transformational integrated student supports available to 1 in 10 Virginia students.

CIS of Virginia celebrated this milestone in September 2023 with a reception bringing together staff members and stakeholders from across the Commonwealth.

The reception included a video message from founding co-chair Senator Mark Warner, as well as remarks from former governor and founding co-chair George Allen, longtime champion Delegate Delores McQuinn, Communities In Schools founder, Bill Milliken, and current CEO and President, Rey Saldaña.

# **2023-24 State Office Highlights**

CIS of Virginia promotes collaboration and excellence throughout the statewide network, advancing a shared mission of transforming student experiences and school cultures through implementation of CIS's evidence-based model of integrated supports.

## **Network Support**

- Hosted two-day CIS of Virginia Network Summit, convening more than 200 network staff and 25 partners for learning and connection
- Conducted **91** training and technical assistance programs including workshops, peer learning, resource sharing, and coaching
  - 24 affiliate-specific and inter-network trainings
  - 37 small group programs
  - 28 network-wide events
  - 263 total hours of training and engagement

# • Provided customized data and evaluation support and training

- Facilitated cross-affiliate collaboration and peer mentoring
- Redesigned the Emerging Leaders Fellowship program to foster leadership development for veteran network school-based staff
- Published monthly e-newsletter focused on learning and professional development for school-based staff
- Supported ongoing utilization of the DESSA tool to assess social-emotional learning needs and make data-driven programming decisions

- Supported establishment of an emerging affiliate, Communities In Schools of Virginia in Southside with new partnerships in Greensville County and Danville.

# **2023-24 Emerging Leaders**










#### **CIS of Richmond**





## Network Growth: Schools & Students Served



#### CIS of Hampton Roads

Advocating at the General Assembly is an important component of CIS-VA's work. In 2024 staff and students from CIS of Hampton Roads participated in a day of visits with their representatives, including Delegate Jackie Glass of Norfolk.



### Scaling for Success: A National CIS Initiative

In February 2023, Communities In Schools, Inc. announced that Ballmer Group was committing up to \$165M to help scale CIS's model of integrated student supports to 1,000 new schools across the country. This initiative established a fund designed to accelerate growth throughout CIS's federated affiliates over a five year period.

CIS of Virginia and its affiliates will have three opportunities to apply for funding, requiring a 50% match and demonstration of public sector partnerships.

In FY24, four Virginia affiliates participated in the first funding cohort, collectively receiving \$5,167,889 over the first three-year funding period, facilitating a new or deeper presence in 37 schools.

The Scaling for Success Initiative will be a catalyst for expansion over the next four years.

# **Community School Implementation Fund**

In the 2023 and 2024 school years, the CIS of Virginia network leveraged \$5M in funding from the Virginia Department of Education's Community School Implementation Fund, an initiative to develop, deepen and expand the community school framework across the commonwealth. The funds were invested strategically by five affiliates to support growth in new and existing partner districts, and elevate overall affiliate capacity. The funding also supported CIS of Virginia's establishment of two new partnerships in the unserved Southside region.


The CIS-VA network was uniquely positioned to turn the Community School Implementation Fund investment into powerful outcomes in the form of improved attendance rates, reduced achievement gaps and successful graduation and grade progression of students most at risk of disengaging or dropping out of school.

The Community School Fund directly increased the CIS-VA total student reach by 27%.




#### Funding Impact: Statewide Reach

# **Communities In Schools of Virginia in Southside**

CIS of Virginia launched an initiative to establish a regional presence in Southside Virginia with two inaugural partnerships with Greensville County Public Schools and Danville Public Schools. Based on a positive experience in one high school in each division, these partnerships have already expanded for the 2024-25 school year, and discussions are underway with several neighboring school districts.


# 2023-24 Financial Report


Investment from the community is essential to our ability to expand CIS's reach in a sustainable manner, support affiliate excellence and report on outcomes. CIS of Virginia is grateful for steadfast partners in both the public and private sectors who share a commitment to ensuring every child's potential is maximized.

In 2023-24, CIS-VA's resource development efforts resulted in more than **\$5.2M in direct support for the affiliate network**. CIS of Virginia administered funds to affiliates that supported growth and sustainability in the form of investment in affiliate infrastructure and leadership, support for new site coordinator positions and ability to deepen impact at high-population schools.


